DAVID IRVINE RUCKER - TEXAS RANGER 1943-1981 By Alice Rucker Allen



The Department of Public Safety announces with sorrow the death of DAVID IRVINE RUCKER, Trooper II, Highway Patrol Service, Region 3, Port Isabel, Texas, who was killed in the line of duty on Tuesday, September 29, 1981. He was employed with the Department on July 31, 1968. [signed]: James B. Adams, Director.

David ("Dave") Irvine Rucker¹ had a very strong desire to become a highway patrolman. He wanted to help others and he was a skilled marksman. His adult life was spent striving to reach this goal.

David was born October 21, 1943, in Brownsville, Cameron County, Texas. He was raised by a family who moved from place to place. His father, Irvine Bracht Rucker was very interested in aviation and was involved in

barnstorming in an aircraft with an OX-5 engine.

Irvine was later recognized as a pioneer in aviation. He went blind in his left eye and was grounded for the rest of his career. He did flight inspections for Pan American world Airways for over 30 years. The family lived first in Kansas City, Missouri then moved to Brownsville, Texas in the late 1930s. He was later transferred to San Francisco, then to Miami,

Florida. The family always considered Texas their home and later returned there to live.

David attended El Jardin Elementary school in Brownsville, Texas (1951-1956) then moved with his family to Homestead, FL. He graduated from South Dade High School, June 3, 1963. While in High School, he worked part time at Bill Franklin food store and at Burger King. He earned enough money to buy a Jaguar sports car. He spent many hours making changes and polishing the engine to look like a show car.

Richard ("Rick") L. Coonce, Chagrin Falls, OH, a high school friend of David described his marksmanship: "Dave and I hunted together both with bows and rifles. I remember once we were hunting rabbits with bows, he had a western style holster. We jumped a rabbit in thick wood, so we couldn't get an archery shot off. Dave drew and fired his revolver in a smooth action that I'd only previously seen in western movies. And he hit the rabbit on the run. Another time, we came upon a snake which wasn't bothering us, but as kids we never left a snake alive if we saw one. Dave wanted to shoot it with the bow, but I protested that he would miss, so took aim with the rifle, intending to take the shot as soon as his arrow missed. I was aiming right at the snake's head when Dave's arrow went through it. I developed a great respect for his shooting."

After high school, David returned to Texas and attended Texas Southmost College (1963-1966) in Brownsville, majoring in Liberal Arts. He had part time jobs at HEB food store and was a carrier for the <u>Brownsville</u> Herald.

David moved back to Dade County, FL, where he attended Dade County Police Academy (1966-Jan 1967), studying Basic Law

Enforcement. He was employed by the Homestead Police Department Patrolman (1966-1968). a While in Florida, he was a member of the National Guard in Miami and a member of the Air Force Reserve where he was a field wireman and lineman and decorated as a sharpshooter using the M-14 rifle. He resigned to return to Texas where he worked as a clerk in the Brownsville Consolidated School district.

He put in his application for employment at the Department of Public Safety (DPS) on May 24, 1968. He had a very strong desire to become On his application, patrolman. David stated that he was 24 years old, 5' 11" tall, weighed 190 pounds, had blue eyes, brown hair and ruddy complexion. He listed his hobbies as: painting, checkering, woodcarving of gunstocks, cabinet work, weight reading, and fishing. lifting, He was mechanically inclined, had done some public speaking and had belonged to the Fraternal Order of Police.

His strong desire for a police career resulted in many recommendations from many friends and former employers.

Records at the DPS at Austin, TX, tell of the many kind deeds that David had done during his work there. He received many letters thanking him for coming to their schools and clubs to talk concerning such topics of interest as traffic safety, the organization of the Department of Public Safety, and other points of law enforcement and public safety.

David Irvine Rucker took the "Oath of Office" of duties of the office of Patrolman in Austin, TX, on July 31, 1968. He finished his training November 22 in Austin, and was assigned to Region 3, Raymondville, Willacy Co., TX, as a Patrolman Trainee. The next May, David was recom-

mended for permanent status, having done an acceptable job and having a definite interest in patrol work. He took the oath of Highway Patrolman September 15, 1969.

David and his wife, Mary Sue Berry, were married June 3, 1966. Three children were born to them: Christy Jolene, born November 15, 1970; Roy Limerick, born July 28, 1972; and Debra Dawn, born December 20, 1973, all born in Cameron David and Mary County, Texas. Sue divorced in the fall of 1974, with Mary Sue getting custody of the two girls and David getting custody of their son. David later married Thelma W. Hobbs in 1976. Thelma had a daughter by a Mary Sue previous marriage. Rucker also remarried and remains in the Edinburg area of South Texas.

David had a great desire to go into the Narcotic service. He had knowledge of some Spanish and he attended Pan American University taking Principals of Law Enforcement Supervision and Basics of Criminal Law.

On September 1, 1973, he was appointed and on Patrolman, December 1 he was promoted to Patrolman II. He requested to go into the Narcotic Service and he resigned on May 29, 1974, to go back to school. He attended Pan American University in Edinburg, TX, and on May 1, 1975, received bachelor's degree in Enforcement.

David then asked for reinstatement with the DPS and was reinstated on June 1, 1975. He requested to go to Port Isabel, Cameron Co., TX, but was assigned to Johnson City, Blanco, Co., TX, instead. Later he was transferred to Port Isabel.

The Department of Public Safety awarded David a certificate for Meritorious Service for ten years of service, in July of 1979. He was commissioned a Peace Officer on

August 31, 1979, just two years before his untimely death.

On the night of September 29, 1981, at approximately 11:04 pm, David Irvine Rucker lost his life while making a routine violator contact. The location was 15 miles west of Port Isabel, TX. The person responsible for the shooting was arrested, tried and was eventually executed at Huntsville, TX, in May 1993.

Letter from David's sister, Donna Rucker Robinett: "Our family went through a lot of trauma during 12 years of trials and appeals for the person who Lionel shot David. Herrera was finally executed in May of 1993, twelve long years Unfortunately, most of later. what his three children and I remember are the news shots of David lying in a pool of blood that were shown each time the case came up. But finally, it is behind us and we can concentrate on remembering the fine man David was."

David Irvine Rucker was a fine man, loved his work, and touched many lives. His family, friends and others were saddened that his life ended so soon and suddenly, and many persons will long remember him and his good works. We can only imagine the accomplishments he would have achieved if his life had not been snuffed out in its prime.

Footnotes

David was the third child of Irvine Bracht Rucker
 (d. 1979) and Hazel Dawn Limerick Rucker

David's lineage: Irvine5 Bracht Rucker; Roger4 Rucker; Irvine3 Coleman Rucker (1847-1916), m. Sara Bird Griggs; John2 Rucker (1811-1881) and wife Arthusa Jane Todd. At this time, John Rucker's parents are unknown. Whitley, p.101, said he was the son of Steepleton5 Rucker (Moses4, Isaac3, John2, Peter1), but as they were both born in 1811 and were the same age, they could not have been father and son. John and Steepleton were both age 39 in the 1850 census of Kentucky. John was listed in Clark County and Steepleton was in Henry County.

^{2.} David's father, Irvine Bracht Rucker, was the son of Roger Rucker (1885-1918) and Verdelia Bracht Rucker. Roger was born 1885 in Kentucky and died 1918 in a swine flu epidemic, leaving Irvine to be raised by his mother.

KEVIN EASTER, SHERIFF'S DEPUTY, KILLED IN THE LINE OF DUTY

Another Rucker descendant has been killed in the line of duty.

KEVIN EASTER, Deputy Sheriff of Sedgwick County, near Wichita, 8, Kansas, was killed January 1996. He was 24 years old. the early morning hours of January 8, Kevin began pursuit of a car full of teen-agers acting suspiciously. Their car went out of control and hit a tree. Kevin began chasing the driver on foot. After a short scuffle, Kevin was shot four times.


The suspect, Sakone Donesay, age 15, was driving a stolen car. He was on conditional release jail burglary from for a conviction.

Doctors tried for an hour and seventeen minutes to revive Easter, but could not. The time of death was listed at 2:50 a.m.

Easter had Kevin recently accepted a job with the Drug Enforcement Agency. He left behind a widow who "would never look into his eyes again, hold him when she cried or be the mother of his children." This was taken from a letter of Julie Easter read to the court.

In addition to his wife, Easter is survived by his mother, Janice ("Jan") Blye Easter, and his brother, Jeff Easter, a Wichita, KS, Police Officer.

Donesay, a teenager, was convicted of first degree murder and was sentenced to the "hard He will serve forty forty." years as the judge felt that he

chose to lead a criminal life and would not be rehabilitated. He also received eight for years theft, aggravated robbery, criminal damage to property and criminal possession of a firearm.

the sentencing mother said brought closure for her family, though her son will always be with them. "The tragedy just ever take away wonderful memories I have," she said. "That's the one thing that that tragedy will not do, I will always have my son in my heart forever."

IN MEMORIAM

ISABELLE PETTIT RUCKER was born June 5, 1918 and died December 14, 1996, in Richmond, VA, of cancer. She was 78 years old. She was the widow of former Rucker Family Society Board member, Albon McDaniel ("Mack") Rucker Jr. (obit in RFSN, Vol. 5, No. 3, p.35, see Wood, p.51).

Isabelle was the only daughter of William Albert Claude Pettit and Gerdena Sherman of Frederick's Hall, Louisa Co., VA. She went to Randolph-Macon Woman's College in Lynchburg and earned a B. A. degree in Latin. She taught school in Arlington, VA, where she met Mack Rucker whom she married June 14, 1941 (50th wedding anniversary, RFSN, Vol. 2, No. 3, p.6).

In 1948 they moved to Louisa County, VA, and bought Bear's Den Farm where they raised cattle and she taught mathematics at Louisa In 1958 County High School. Isabelle was granted participantship in the National Science Foundation's first Academic Year Institute in Mathematics at the University of Virginia. earned a M.Ed degree in mathematics and was offered the position of state supervisor of Mathematics by the Virginia Department of Education -- the first of its kind in Virginia. She continued in this position until 1973 when the General Assembly of Virginia created the first Governor's School for the Gifted -- a summer school session held in different locations around the state. She was appointed the school's first state director, a position she held for seven years, retiring in 1979.

Isabelle co-authored a set of mathematics textbooks and was active in numerous organizations related to her work. She

received many academic accolades being the including recipient of the Distinguished award in Mathematics Service Education given by the Greater Richmond Council of Teachers of Mathematics. She was honored by Randolph-Macon Woman's College in 1984 with membership in Phi Beta Kappa and named one of three alumnae to be recipient of the Alumnae Achievement Award 1986.

Isabelle was a member of Seventh Street Christian Church, the Tuckahoe Woman's Club, the Riverside Garden Club and Ikebana of Richmond. Her hobbies included fishing, gardening, golf, entertaining and needlework. Her last few years were spent at Westminster-Canterbury House, a retirement home in Richmond.

Isabelle and Mack Rucker are buried at Bethpage Christian Church, Frederick's Hall, VA.

RUCKERS OF THE 10TH TEXAS INFANTRY

Scott McKay of Roswell, GA, is preparing a history of the 10th Texas Infantry, comprised of military records, along with letters, diaries, and reminiscences of the soldiers themselves. Pvt. George W. Rucker - age 22, when enlisted with Co. B, 10th Texas Infantry, at Virginia Point, Galveston, TX, on Nov. 9, 1861. He was recruited at Springfield, Limestone Co., TX, four days earlier. He was captured at Arkansas post on Jan. 11, 1863 and was exchanged at City Point, VA, six day later. Pvt. Rucker was transferred to Co. K, 31st Tennessee Infantry, on Jan. 23, 1864.

3Sqt. Edmond T. Rucker - age 21 upon enlistment as Private with Co. G, 10th Texas Infantry, at Houston, TX, on October 31, 1861. Pvt. Rucker was promoted to 3Sqt. on January 1, 1862 when 3Sqt. Sharpe left a vacancy by being promoted to Regimental Sqt. Maj. 3Sqt. Rucker was captured at Arkansas Post on January 11, 1863. He escaped from the enemy at Alton, IL, on January 27, 1863. His last military record listed him "Absent In Trans. Miss. Dept."

Pvt. Jeremiah T. Rucker - age 32 at enlistment with Co. K, 10th Texas Infantry, at Coryell Co., TX, on March 3, 1862. He stood 5'6" tall with blue eyes and dark hair. Rucker was a farmer with a wife and three sons residing at Station Creek, Coryell Co., TX; his oldest son was age 12 and the youngest age 3 1/2. He and his sons were born in Missouri and

his wife was born in Georgia. Pvt. Rucker was detailed as a "Cook" from May 22 to June 22, 1862. He was captured at Arkansas Post on January 11, 1863, and arrived from there to Camp Douglas Prison on January 29, 1863. He deserted by taking the Oath to the Union, at Camp Douglas Prison on March 5, 1863.

Editor's note: There is only thing the Editor can add is that Jeremiah T. Rucker married Martha Shelnut, July 15, 1847, in Boone Co., Missouri.

PROPOSAL - HIGHWAY MARKER FOR RUCKERSVILLE, GEORGIA

The Rucker Family Society has decided on a project to erect a highway marker in Ruckersville, Georgia. It will commemorate the town and its founder Joseph Rucker, known as Georgia's first millionaire.

Julius ("Jule") T. Rucker, of Evans, GA, RFS board member, has graciously agreed to head up this project. He will obtain the necessary documents and submit the forms to the Georgia Department of Transportation. However, the Rucker Family Society will pay the costs. We ask your

support in this endeavor.

A history of the area is given in <u>Life of Joseph Rucker</u> Lamar, by Clarinda Pendleton Lamar, 1926, p.17-18: "In 1784 the General Assembly of Georgia set apart two hundred thousand acres of land in Wilkes County to be settled by Virginians, and in the last quarter of the 18th century, many Virginians were moving to Georgia. When one remembers the numerous children mentioned in the Rucker wills, one is not surprised to learn that the state of Virginia became a little overcrowded with Ruckers and then, in 1785, Pressley, Willis and William Rucker came from Virginia to Georgia located in what are now Elbert and Hart Counties. They sent back a good report as to soil and climate and early in 1786, John Rucker, fourth in descent from [Peter], came with his wife, Elizabeth Tinsley, from Ruckersville, Virginia, to a neighborhood in Elbert County, which soon became known as Ruckersville, Georgia. He settled on a tract of land still owned by his descendants. 'And there, on the fifth day of January, 1788, his son Joseph was born, and there he spent the seventy-six years of his life, and there, on the twenty-seventh day of August

1864, he died.'"

Joseph Rucker was the son of John⁴ Rucker (Cornelius³, Thomas², Peter¹) and Elizabeth Tinsley. Joseph married in January 1812, Margaret Houston Speer, daughter of William, who lived at Cherokee Falls, on the Savannah River.

The following excerpts on the history of Ruckersville, GA, were taken from publications at the

Elberton public library.

Ruckersville was a small community of 200 in antebellum days, incorporated December 9, 1822. It was located along the banks of the Savannah River in Elbert Co., in the northeastern section of Georgia. Its history can be traced back to Virginia and that time of immigration which began about 1786. . .

In 1827 <u>Sherwood's Gazetteer</u> described Ruckersville, GA, as containing "ten houses, six stores and shops, an academy, and a house of worship for the

Baptists."

Later it became a thriving town of 600 or 700 people, fifty? stores, a newspaper, two banks, two schools, and two churches. A Princeton graduate became the principal of its academy.

Today there is no sign of the former village of Ruckersville There are no businesses or stores. Only two churches and a few homes remain to remind one of

the once booming town.

Jule Rucker has contacted the owners of the former Rucker land, descendants of Joseph Rucker. They have given their permission for us to place a marker on their land.


