## Ruckers and Enslaved "Fortification Men"

Records at the National Archives and at subscription services such as Ancestry.com shed light on how enslaved labor was employed by the Confederate Army in the Civil War. Genealogy on Black families is difficult since enslaved Blacks were not enumerated by name in censuses prior to 1870. "US, Confederate Army Payrolls for Enslaved Labor. 1840-1883" is a searchable database which can be accessed at Ancestry. It provides the first names of enslaved people rented out to the Confederacy for labor on military defenses, and the names of their slave owners. This record group may answer the occasional question I get from African American genealogists seeking the connection between their ancestors and the descendants of Peter Rucker.

### **Enslaved Men**

The following data was obtained by searching the database for "Rucker" in Virginia counties.

In Amherst County, Daniel H. Rucker received \$20 for the labor of "Nelson." Valentine H. Rucker received \$20 for the labor of "William Button." William Rucker rented out "Armistead" for \$20 and "Daniel" for \$41, who worked for seventy-eight days at sixteen dollars a month building artillery fortifications. Nathan D. Rucker received \$41 for the labor of "Wyatt" on the Richmond Defenses. Ambrose C. Rucker received \$25.33 for the work of "Sam" in Richmond, Addison C. Rucker provided the laborer "Gustavus" for sixty-five days of work in Richmond, receiving \$43.33.

In Bedford County, "Jack" was rented by Moses P. Rucker to work on the Chaffin Bluff Brooke Defenses in Richmond, for sixty days and \$32. James M. Rucker received \$32 dollars for the sixty days of work done by "Henry" and \$41.60 for that of "Stephen," who was twice rented out for labor. Bernard Rucker provided "Fuller" to

work on the Lynchburg fortifications.

In Campbell County, November 1863, John Rucker and son rented out "Reuben," "Barnes" and "Fleming" for twelve days work in Lynchburg. George M. Rucker provided "Sandy." These named slaves were again rented in December for twenty-six days. In January 1864 these Ruckers received no pay for the work of the four, because Barnes ran away on 24 December and the other three on Christmas Day.

In Greene County, William and Willis Rucker received pay for two months of labor performed by "Andrew."

Since freed slaves may have taken the same surname as their previous owners, a search of postwar censuses can identify a man who was rented out by a Rucker during the Civil War. For example Gustavus Rucker is in the Amherst County VA census of 1880, born about 1844, married to Josephine with five children in the household. This is likely the same "Gustavus" rented out by Addison C. Rucker in Amherst County during the Civil War. Nelson Rucker is in the 1870 Amherst census. born about 1835, married to

Paulina, with five presumed children. This is probably the man whose slave labor in the Civil War accrued to Daniel H. Rucker. I suspect that my direct ancestor, William Ambrose Rucker, provided "Armistead" as a so-called "fortification man" and that Armistead is in the 1880 census of Bedford County. married to Susan with four presumed children at home. Wyatt Rucker, who was enslaved by Nathan D. Rucker, is probably the man in the 1870 and 1880 censuses of Lynchburg, working with his children in a tobacco factory.

### Sabrina Rucker

Rucker previously started another business called Winter-Whittler, where she sold basswood carvings of penguins. She secured second place for the carving business in the Minnesota chapter of the Global Student Entrepreneur Awards in 2021.

# Rucker Family Society Reunion Monterey, California October 13-16, 2022

What a magnificent place to have a Rucker Reunion; the beautiful coast of Central California. About 65 Ruckers, including family and friends, met in Monterey from October 13<sup>th</sup> to 16<sup>th</sup>, 2022 to share family fun, meet new relatives and enjoy the beauty of this part of our country.

Those who arrived on Thursday had the opportunity to spend some time (shopping and dining) in the picturesque village of Carmel by the Sea, a charming little town with a "gently" sloping main street that takes you to a beach on the Pacific Ocean. Carmel has a lovely shopping district with many boutiques and interesting shops and the local homes are picturesque cottages (that do not have numbered addresses. but house names!) Their enthusiasm and knowledge of the customs and traditions of these settlers of the original Spanish Land Grants was extensive and interesting.

While some members chose to spend the day walking along the bay or visiting Fisherman's Wharf, many of us headed down to Cannery Row in Monterey for a visit to the Monterey Bay Aquarium. As with many local aquariums, this one is dedicated to the fish and marine wildlife that make the Monterey Bay their home. Of course, one of the highlights is watching the fish being fed and especially watching the frolicking sea otters.

Our evening presentations began with opening remarks from our President, Christopher Rucker, followed by a clever and engaging "Interview" with our Great+ Grandmother,

Elizabeth Rucker, the wife of Peter Rucker! Our lovely "Grandmother" arrived in a beautiful pink gown that was typical of the early 1700's and was interviewed by Karen Rucker van der Werf. We were all enchanted with the insights into the life of our ancestors in early Virginia and the details of our family. "Grandmother" gave us an amazing glimpse into our family history; she was delightful, charming and amusing, just like we would expect her to be. I believe that most of us would have loved for her to speak with us all evening; but we are Ruckers. and it was time for dinner! (By the way, this excellent and engaging presentation was written and acted by sisters, Shirley Rucker Klein from Provo, UT and Karen van der Werf of Pine, AZ.) Well done, ladies!.

Following dinner, the Y-DNA project's presentation "Once

Upon a Time" began with Alice Rucker's introduction of Paul Mize. Very interesting findings here - there will be more about his presentation in a subsequent article in the Newsletter.

Saturday morning began with another wonderful breakfast after which we went to "San Carlos Borroméo de Carmelo" aka the Carmel Mission Basilica. Our delightful guide spoke to us about the choice of this location for Fr. Junipero Serra to build the 2<sup>nd</sup> of the Alta California Missions in 1771 (there were 21 Missions in total) and the relationship with the local



peoples.

We toured the museum, which has one of the most extensive collections of mission-period artifacts in California. Alice Rucker even sang one of the chants that

music book in the museum – the singers used to all share the same book! We toured the Basilica (Church) and a second tour guide joined us to talk about the architecture, history and significance of this mission. St. Junipero Serra is buried in the Mission Basilica.

Then, we were on our way to the National Steinbeck Center and Museum in Salinas, about 20 miles away through the beautiful Salinas farmland. The Steinbeck Center, a literary museum, dedicated to the works and life of John Steinbeck, the "author of the common man." We enjoyed the immersive, interactive museum complete with clips from many of the films that have been made from his books. The museum graciously invited us to have our box lunch in the lobby and on their patio.

After a full day of activities we returned to the hotel for another evening of entertainment.

Laughing through several rounds of "Rucker" Bingo (did Roger Settlemire really win all four rounds?), we then enjoyed dinner followed by a presentation by Christopher T. Rucker about the first of our Rucker relatives to migrate to California.

We discovered that William Campbell and his son Benjamin (the founder of the town of Campbell, CA near San Jose) traveled via wagon train with the ill-fated Donner party. [They tried a new route and were delayed by a multitude of mishaps. They spent the winter of 1846–1847 snowbound in the Sierra Nevada mountain range.]

Fortunately, under the leadership of William Campbell, a group decided not to take the fateful "shortcut" and made it safely to Mission San Jose in the Santa Clara Valley without the tragedy that befell

the Donner Party. Finding California to be a place to make a home and a fortune, William's son, Benjamin Campbell returned to Missouri to marry his sweetheart, Mary Louise Rucker and they returned to settle in the Santa Clara Valley of California joined by many of her Rucker family members.


It's interesting to also note that Loren Rucker's great-grand-father's sister, Sara Rucker, married Bill Imus who was reportedly one of the Scouts on the Donner Party – it's a good thing he made it through that dreadful winter in the Sierra Nevada Mountains!

As with every Reunion, we followed this presentation with a very lively Rucker Auction run by Mike Rucker! Lots of laughs and lots of bidding resulted in quite a fun and profitable evening.

Throughout the Reunion (from Thursday morning until Sunday afternoon) there was a Rucker History Room, filled with books, pictures of Rucker family members and Rucker sites, two quilts made by Verona Flint's Rucker greatgreat-grandmother in the mid-1800's before the Civil War, newspaper articles, scrapbooks and memorabilia from different Rucker families in California. Since this was also a gathering place for attendees, many of us

enjoyed all of the history offered here.

As a special tribute to our Rucker families that migrated



to California, 20 of our members wrote stories about their own family's migration to Virginia. We compiled these stories into a booklet to share with everyone who attended the Reunion.

The minutes for the last meeting, June 6, 2019, at Sweet Briar College, Amherst, VA were read and with no additions or corrections noted were approved.

Treasurer's report: Balances of accounts through August 31,

2022 were presented and compared with balances of last meeting, March 2019.

Speeding up communication between registrar and treasurer was mentioned. Balances and activity of the Y-DNA General Fund at Family Tree DNA were presented. Because our Ruckers are of Celtic Y-DNA it was suggested to change our newsletter header to something more appropriate than current Germanic.

### Harriet Weatherly Berry Jewell

Harriet Weatherly *Berry* Jewell of Lebanon, Tennessee, died July 15, 2022. She was the daughter of Charles Vernon Berry (1921-2006) and Earline Carothers Berry. Harriet was married and divorced and had no children.

### Winfred<sup>7</sup> Leeper Rucker and Lemuel<sup>7</sup> Mitchell Clay

On page 30, see the photo of two uniformed Spanish-American War soldiers, sent by Nina Cole of Grand Island, Nebraska, daughter of Lemuel Mitchell Clay. The inscription says: "(Dad) Lemuel Clay (right) cousin Fred Rucker? 1898 Phillipi Island."

A little sleuthing provides the story of these first cousins.

Lemuel Mitchell<sup>7</sup> Clay's Rucker line is: Mary<sup>6</sup> Elizabeth Rucker [m. William H. Clay]. Lemuel<sup>5</sup> S., Ambrose<sup>4</sup>, Lemuel<sup>3</sup>, James<sup>2</sup>, Peter<sup>1</sup>, He was born 6 December 1872 and is first enumerated in the 1880 census of MO, Harrison Co., Dallas, E.D. 298, #73, a son of William H. and Mary E. His father, William H., was a Union veteran of the Civil War and served in Company K, 5<sup>th</sup> W. VA Infantry. Lemuel married first Rose Elizabeth Simpson, second Margaret Jane Dolen and is in: the 1895 census of Kansas, Butler Co., Towanda; the 1900 census of NE, Custer Co., Ansley, E.D. 58, #43; the 1920 census of NE, Sheridan Co., Antioch, E.D. 230, #203; the 1930 census of CO, Morgan Co., Precinct 16, E.D. 20, #63; and the 1940 census of NE, Custer, Ansley, 21-3, #97.

Lemuel's WWI draft card describes him as stout, 5'11" tall with blue eyes and brown hair. He died 5 July 1942 and his family received a Veterans Administration headstone for his grave, as did his father. Both are buried in the Ansley Cemetery in Custer County, Nebraska.

Winfred<sup>7</sup> Leeper Rucker's line is: William<sup>6</sup> Leeper Rucker. Lemuel<sup>5</sup> S., Ambrose<sup>4</sup>, Lemuel<sup>3</sup>, James<sup>2</sup>, Peter<sup>1</sup>. Winfred was born in May of 1876 and is first enumerated in the 1880 census of MO, Harrison Co., Dallas, E.D. 298, family #156, a son of William L. and Martha F. His father, William L., was a Civil War Union veteran, a hospital steward in Co. C of the same regiment as William H. Clay. Winfred married Elsie Day and is in: the 1895 Kansas state census, Jackson Co., Whiting, #8; the 1900 census of MO, Daviess Co., Union, E.D. 62, #418; the 1910 census of MO, Grundy Co., Trenton Ward 2. E.D. 59, #53; the 1920 census of KS, Morris Co., Council Grove, E.D. 89, #18; and the 1930 census of CA, Los Angeles, E.D. 109, #421. He died 19 Sept. 1934 and is buried in the Los Angeles National Cemetery with a headstone from the Department of Veterans Affairs.

Private Lemuel M. Clay and Corporal Winfred L. Rucker were in Company M of the 1<sup>st</sup> Nebraska Infantry. Clay was a wagoner, enlisted 27 April 1898, and discharged 23 August 1899. He applied for a military invalid pension 18 April 1921. His cousin Winfred enlisted the same day and was discharged 12 December 1898, probably for illness, since he quickly applied for an invalid pension 6 March 1899. Winfred again served from 15 August 1917 to 21 Jan. 1919 as a captain in the US Army Quartermaster Corps.

The 1<sup>st</sup> Nebraska Infantry was part of the Philippine Expeditionary Force sent to fight against the Spanish. It arrived in the Philippines 17 July 1898 and fought in the 13 August attack on Manila, the same day the armistice was signed. The Treaty of Paris ended the war on 10 December. and Rucker was discharged two days later. Clay continued fighting against the Filipinos in the Philippine-American War. His unit was in many engagements and arrived back in the U.S. 29 July to be mustered out in August.

The photo shows the men with outdated Indian War-era "trapdoor" Springfield rifles, often issued to state regiments in place of the modern Krag-Jorgensen rifles issued to regular Army regiments. There are no clues in the photo to its location, but it was likely made stateside during training camp.



The photo of two uniformed Spanish-American War soldiers was sent by Nina Cole of Grand Island, Nebraska, daughter of Lemuel Mitchell Clay. The inscription says: "(Dad) Lemuel Clay (right) cousin Fred Rucker? 1898 Phillipi Island."
